Minutes of Meeting, 7 December 2022

The meeting was held at the Forney Transportation Museum, 4303 Brighton Blvd., Denver CO

The meeting was called to order at 7:31 pm MDT, by President Dick Thompson. 23 member clubs, two individual members, and two guests were in attendance. Officers present were President Dick Thompson, 1st Vice President Tom Mansfield, 2nd Vice President Calvin Craig, Treasurer Samantha Baker, and Secretary Richard Fritz.

Guest Speakers: Mike and Jim McCutchen are seeking advice about selling vehicles from an estate left by their late father. The vehicles include a 1961 Ford station wagon and a 1964 International pickup truck. Both are not drivable and without titles. They will need information about getting titles for these vehicles. They were advised to check with the DMV and go through the process relying on a bill of sale and bonding when sold and to go to local swap meets to explore interest in the vehicles. Mike's phone number is 303-521-3821.

Legislative: Leo Boyle noted that the November election will result in new and predominately Democratic legislators on committees but key legislators we have worked with on the Transportation committees will be around. He reported that he will be meeting with the person most responsible for drafting legislative bills to seek clarification of SB19-054 which has been interpreted to mean all surplus military vehicles can only be licensed to be driven off-road like farm tractors. Leo also expects bills dealing with the metro area's ozone violations.

Minutes: The minutes of the November CCCC meeting were approved after correction of the date of this meeting.

2023 Budgets: Proposed budgets for the 2023 Operating, Government Relations, and Car Show / Swap Meet Accounts were presented and discussed. The budgets are basically the same as 2022 but with adjustments such as inflation. Each budget was accepted and voted in favor. Renewal dues and assessments remain unchanged.

CCCC shirts: Additional shirts will be ordered for delivery in 2023. Contact Dick Thompson.

Concours d'Elegance: Discussion with Tom Scott regarding the June 4 2023 Concours in Littleton is continuing. The Concours is planning to feature evolution of the automobile with decades of vehicles grouped together. CCCC is urged to promote the show and provide 50 cars.

Pharaohs Car Club Car Show: The Pharaohs club has expressed interest in joining CCCC in 2023 and has invited CCCC members to their Car Show on June 10 in Northfield. Dick Thompson has met with their officers and has arranged for the show's benefit to go to CCCC.

2023 RMMA (Jeffco) Airport Show: Dick Thompson reported that the August 5th 2023 event may relocate to a different part of the airport which would afford parking on grass rather than concrete.

Forney Museum Dust & Shine events: Contact for scheduling D&S dates for clubs is Gary Canady at 303-264-9953, not Dick Thompson.

Presidents' Night: The annual club presidents' night will be February 1st, 2023 and held at Rocky Mountain Metro Airport terminal building. There will be food provided.

Colorado Parks Pass ("Keep Colorado Wild Pass"): The Parks Pass will go into effect on all registrations beginning January 1, 2023. There is an "Opt Out" provision rather than Opt In, meaning the fee can be declined and the registration reduced by \$29. The Pass if accepted is not transferable between vehicles. Only state parks are covered, not national parks such as RMNP. Vehicles without the pass can still enter state facilities by paying a day use fee.

Early 2023 Swap Meets: Polar Bear Swap meet will be at Adams County Fairgrounds, January 28. Info: 303-378-1321. The Sabres Tri-States Swap Meet at the National Western Complex in north Denver will be Feb.4-5, Info: 303-428-6046.


Next Meeting: There will <u>not</u> be a January meeting.
