Minutes of the 4 December 2024 Meeting

The meeting was held at the Forney Museum of Transportation, 4303 Brighton Blvd., Denver CO. 21 member club representatives were signed in as was one individual member and a guest, Mark Milliken from the Oil Capitol Auto Club. Officers present were Dick Thompson, president; Tom Mansfield, 1st vice president; Calvin Craig, 2nd vice president; Dick Fritz, secretary and Samantha Baker, treasurer.

The meeting was called to order at 7:27 pm.

Mary Sue Powell, Bill Miller's friend, announced that Bill had passed away from the stroke he suffered a month ago. Keith Robinson will serve as the Shelby Club's representative.

Ted Rossi: Dick Thompson and Leo Boyle have met with Ted, who is recovering but he is not ready to resume his role with the "Friends of Collective Cars" PAC and that work will be on hold for now.

Minutes from the October meeting were accepted as published.

Treasurer's Report was approved.

Legislative: Leo Boyle reported that the Legislature will reconvene on January 8th and committee appointees will be decided by that date. We will learn who will be on the transportation committees since they are the ones most likely to influence collector vehicles. Concerns about the unsolved atmospheric ozone problem may bring about restrictions on older cars on the road.

Historic Military Vehicles: Anticipating legislative action (perhaps a new bill) we will seek to learn how many military vehicles are currently owned in Colorado.

RMMA Airport Show 2025: Rick Ruel of the Cobra club has volunteered to be the chairperson of the 2025 show. The airport staff has told us that they no longer can provide drivers for the hay wagons that transport spectators to the show from parking lots due to insurance issues. We will explore other options, such as using pickup trucks or larger golf carts.. Other ideas would be welcomed.

Nomination of 2025 CCCC officers: Nominations for CCCC officers (President, 1st and 2nd Vice President, Secretary, and Treasurer) were reopened. Samantha Baker has requested that she be replaced as treasurer. Tom Mansfield was nominated to be treasurer in 2025. John Ehrlich was nominated to become 1st vice president. Dick Thompson (president), Calvin Craig (2nd vice president), and Richard Fritz (secretary) are nominated to continue in their present positions. No additional nominees were presented and the candidates were elected by acclamation. Dick Fritz announced that he will temporarily continue as secretary but will need to be replaced for health reasons.

Budgets: Dick Thompson and Samantha Baker presented an excel spreadsheet showing 2024 income and expenditures, with projected finances through the end of 2024 and the proposed 2025 budgets. Approval of the Operating budget was moved by John Mack, seconded by Calvin Craig and passed unanimously. Approval of the Government Relations budget was moved by John Mack, seconded by Calvin Craig, and passed unanimously. Approval of the Car Show & Swap Meet budget was moved by John Mack, seconded by Calvin Craig, and passed unanimously. Dues and Assessment (legislative) will be unchanged for 2025. Renewal forms will be sent out later in this month.

Website: The CCCC web site (www.collectorcouncil.com) will continue to include copies of the minutes for one year only. Clubs are urged to check out details related to their club (contact person, events, etc.). By council policy, the web site will not promote events sponsored by non-CCCC-clubs.

January-February 2025 meeting: There will not be a CCCC meeting on January 1st. The Council's next meeting will on Wednesday, February 5th at The Rocky Mountain Metro Airport (Jeffco) in Broomfield. This will be our annual Presidents' meeting, to which every club's chief executive is invited. Traditionally pizza and soft drinks are provided. At this meeting, the proposed Bylaw Amendments (introduced at the September 3rd CCCC meeting) will be brought up for a vote.

The meeting was adjourned at 8:26 pm.

Make your dues and event payments with Zelle

Zelle is an online service provided by your bank that allows you to send money from your bank account to LGCA's bank account. Here's how it compares to other payment methods.

Cash payments can only be made at the monthly meetings.

Check payments cost you \$0.68 for postage and take 1 to 3 days for delivery.

PayPal payments cost you and LGCA. On a \$20 event fee you pay \$0.88 and LGCA pays \$1.22. It takes 1 to 3 days to transfer payments from PayPal to LGCA's bank account.

Zelle payments are free. No charge to you. No charge to LGCA. It takes 1 to 3 minutes to transfer the money from your bank account to LGCA's bank account.

Zelle is easy to use. It's one of the menu choices on your banks online banking service. To send money you need to provide LGCA's Zelle credentials. They are:

Zelle Instructions

- 1) Login to your online banking account
- 2) Select **Send Money with Zelle** from menu
- 3) Click on **Send**
- 4) Select recipient and enter amount
- 5) Click on **Review**
- 6) Click on **Send**
- 7) Click on **Send**
- 8) You will get an email confirming the payment was sent

Zelle is a fast, safe and low-cost method of making dues and event payments. I ask you to consider using it.
